I agree to the price of **\$150.00 per hour with a minimum fee of \$40.00** for this service to be performed.

The County of Paintearth No. 18 will not provide any private lane snow removal service if this procedure is not followed.**

**In the event of an emergency, contact the Chief Administrative Officer Tarolyn Peach 403.741.6203.**

**If the grader has already gone past your residence it may be at least three working days before your lane will be plowed. If the grader has to make a special trip to do your lane, this service will be billed by the hour.**

I recognize and defer to the road clearing priorities as established by the County of Paintearth No. 18. I further realize that unforeseen emergencies, public roads and school bus routes are of primary concern to the County and the rate payers at large within the context of this Agreement. I agree to indemnify and hold harmless the County of Paintearth No. 18, its employees' and agents from any and all claims, demands, actions and costs whatsoever that may arise directly or indirectly out of any act or omission of the County, its employees' or agents in the performance of this Agreement.

I understand my responsibility, under the current County of Paintearth No. 18 policy, to submit payment in full within 30 days upon receipt of a service invoice from the County of Paintearth No. 18.
