# EMERGENCY MANAGEMENT AND PREPAREDNESS

The County recently completed a series of training and exercises with our urban partners in a Emergency Management Program. Over a year and half in development, the REMP was developed for all partners to come to the aid of each other, with known practices and procedures the event of a in emergency. With comparatively similar EM bylaws, plans, and a partnership document all signed by the partner muni's, the REMP process was funded largely in part by an ACP (Alberta Community Partnership) grant from the Province of Alberta. With simulated evacuations in Halkirk and Coronation, and large fire response like that of May 2023, all muni's and responding personnel were given ESS (Emergency Social Services) training as well as event experience. Moving forward the municipalities also stress the importance of our individual plans for preparing for an event should strike disaster your farm site, residence/acreage. What will you do? - and how fast can you do it? - when trouble is imminent. That is the question we hope you ask

## **PLANNING AND DEVELOPMENT**

The County has had a busy year with industrial developments within the County, as well as a number of residential projects throughout. With the recent completion of Halkirk 2 Wind Project that marks the 3<sup>rd</sup> wind project in 3 years within the County. Notwithstanding one turbine's mechanical issues (warranty of construction or material failure unknown at this time) the County does reap significant assessment from such industrial projects that help fund County operations and ensure financial viability for a lengthy future. The (Central East Transmission transmission line in the NW corner of the County is under construction currently and planned to be completed in the County by the Christmas break. Pending in 2025, there are some large utility scale solar projects that may be commenced within the County, please watch for the notices of those permits if applied for in 2025. The County also recently completed a land sale of a newly developed lot in the hamlet of Fleet, with more available for sale. Also, the Crowfoot Crossing Industrial Park is undertaking a sewer connection service with the Town of Castor, and having more lots prepared for sale in 2025.
